**The Direct Debit Guarantee**

- If there are any changes to the amount, date or frequency of your Direct Debit, CAF Re Devon Birds will notify you ten working days in advance of your account being debited or as otherwise agreed. If you request CAF Re Devon Birds to collect a payment, confirmation of the amount and date will be given to you at the time of the request
- If an error is made in the payment of your Direct Debit, by CAF Re Devon Birds or your bank or building society, you are entitled to a full and immediate refund of the amount paid from your bank or building society – if you receive a refund you are not entitled to, you must pay it back when CAF Re Devon Birds asks you to
- You can cancel a Direct Debit at any time by writing to your Bank or Building Society. Written confirmation may be required. Please also send a copy of your letter to us.
